She has been a member of the Federal Circuit's Advisory Council and a member of the Federal Circuit Bar Association's board of directors. Addy is a founder of the Richard Linn American Inn of Court, which is directed to intellectual property, and she served as its first president.

Addy counsels companies in the software, technology, biotechnology, and pharmaceutical sectors on the most efficient strategies for realizing their IP goals. Clients describe her as "an exceptionally skilled lawyer" and a "key figure, who knows the courts inside and out" adding that she is "extremely pro-business. She is appreciated for her ability to explain complex legal and technical issues to jurists and laypeople alike—in part because of her training as an electrical engineer.
